#### E-Comm 9-1-1 PSAP service results

- D. Watson provided a short summary on the E-Comm PSAP service levels for 2016 and also answered questions regarding abandoned call rates plans for education.
- J. Steel confirmed that funding for a general awareness campaign including radio and print advertisements, has been included in the 2017 recommended budget. The education initiative is targeted for May 2017.

# E-Comm PSAP call answer service contract

- D. Watson provided some background with regard to the call volume estimates relied on for the for call answer service contract.
- W. Byrne advised the board that the PSAP call volumes had been under reported for the first couple of years of the E-Comm agreement and that the circumstances had only recently been brought to the attention of both parties. Under the terms of the agreement the annual rate is based on call volumes and is subject to change if there is an increase of more than 3% of the base year.

Wells/Stanhope: "THAT the first amendment to the 9-1-1 call answer centre service contract and Schedule "D" revised January 11, 2017 be approved effective January 1, 2017;

AND FURTHER THAT the 2017-2021 financial plan reflect these new levies;

AND FINALLY THAT the NI 9-1-1 President and Secretary be authorized to sign the amendment."

# 2017 - 2021 Financial Plan

W. Byrne provided an update on 2016 surplus shown in the 2017 recommended budget. Most changes attributed to securing final figures on 2016 expenditures. The minor adjustments made since the provisional budget was approved will not affect the 2017 requisition.

The tax rate levy per \$1,000 remains at the same rate as 2016 at \$0.66.

Wells/McNabb: "THAT the North Island 9-1-1 2017 recommended budget be adopted."

# Peace River Regional District fire dispatch services – contract award

D. Oakman advised the board that the Peace River Regional District wished to enter into an agreement with the NI 9-1-1 Corporation for fire dispatch service, based on the proposal submitted by NI 9-1-1 in July 2016. There has been significant dialogue between the two districts as questions arise.

There has been significant media attention in the PRRD region regarding the announced fire dispatch services contract being awarded to NI 9-1-1. The City of Fort St. John have not committed to participating in the service. Peace River Regional District advise that the City has until Feb 27<sup>th</sup> to make a decision regarding participation in the service.

Stanhope/Wells: "THAT the North Island 9-1-1 Corporation enter into an agreement with the Peace River Regional District for fire dispatch services for a five year fixed fee agreement in the amount of \$635,476.74.

AND FURTHER THAT should the City of Fort St John be excluded from NI 9-1-1 fire dispatch service contract the North Island 9-1-1 Corporation enter into an agreement with the Peace River Regional District for fire dispatch services for a five year fixed fee agreement in the amount of no less than \$368,058.57 subject to final review of financial cost analysis and technical requirements"

Stanhope/McNabb: "THAT the recommendation be separated into two motions."

Wells/McNabb: "THAT the motion be deferred to the March 10<sup>th</sup>, 2017 meeting of the NI 9-1-1 board."

# RFP – fire dispatch services

B. Pearson advised the board that the Regional District of Central Kootenay (RDCK) and Regional District of Kootenay Boundary (RDKB) have each issued requests for proposals (RFPs) for fire dispatch services.

McNabb/Stanhope: "THAT a letter be sent to the Regional District of Central Kootenay and the Regional District of Kootenay Boundary thanking them for their interest in having the North Island 9-1-1 Corporation submit a proposal for fire dispatch services; AND FURTHER that after careful consideration NI 9-1-1 Corporation will not be submitting a proposal at this time due to technical incompatibilities with radio communication infrastructure, mapping and timing of the project in conflict with other commitments."
